GLA exists to serve the legal needs of artists and arts organizations, to educate artists and arts organizations about their legal rights and responsibilities and to promote contact and understanding among members of the legal profession and the arts community. GLA, through its network of volunteer attorneys, provides legal assistance to musicians, songwriters, photographers, sculptors, dancers, filmmakers, painters, actors and artists from many other disciplines who would not otherwise be able to afford legal representation and counseling respecting their rights and interests in their works. GLA also makes referrals to experienced member attorneys for artists and arts organizations that do not qualify for free legal services. GLA conducts approximately 50-60 free or low-cost educational seminars and workshops on numerous legal and business-related topics. GLA also has frequent walk-in clinics where artists can meet with volunteer attorneys to discuss various issues and legal questions. GLA has an extensive resource library and provides mediation services as a means of resolving artists' legal disputes. GLA has members representing all arts disciplines, as well as attorneys, accountants and other friends of the organization.
